The Sanford Airport Authority, hereinafter called "Owner," hereby requests sealed bids for "**RUNWAY INCURSION MITIGATION (RIM) & HOT SPOTS**" (Project), at **ORLANDO SANFORD INTERNATIONAL AIRPORT**.

The project can generally be described:

- Base Bid
 - Modifications to the intersection of Runway 9R and Taxiway R via pavement removal and/or placement of artificial turf, as well as updated/relocated signage, lighting, and striping.
 - Modifications to the intersection of Runway 18-36 and Taxiway C, which includes marking removal, signage relocation, and additional markings (including surface painted signs and enhanced centerline markings).
 - Replacement of two (2) 7.5 KW regulators (one serving Taxiway B west; one serving Taxiway C east) in the airfield lighting vault.
 - Cleaning/Restriping of Runway 18-36.
- Additive Alternate #1
 - Modification of the circuiting on Taxiway C and Runway 9C-27C, as well as new lighting and signage on Taxiway C and Runway 9C-27C.
- Additive Alternate #2
 - Replacement of select trapezoidal signs throughout the airfield.
- Additive Alternate #3
 - Replacement of select Runway 9R-27L HIRLs.
